

Consent to the treatment of personal information – Registration to the convention

Subject: Notice regarding the treatment of personal information for the registration to the **international conference iesa20**, under Art. 13 European Union Regulation n. 2016/679 – “General Data Protection Regulation n. 679/2016” (GDPR).

Dear friends,

With this notice, LuovoDiColombo would like to provide to the individuals who wish to register to the conference above, information on the procedure and purposes for the treatment of personal information.

1. Data treatment owner.

The data treatment owner for your personal information is LuovoDiColombo A.P.S. ONLUS with headquarters in Via Montemagno n° 29 -10132 Turin – tel. 011 18837006, e-mail info@infoluovo-di-colombo.it. (hereinafter the Owner)

2. Data treatment purpose.

Under Arts. 13 and 14 of EU Regulation, n. 2016/679 we inform you that the treatment of your personal information and contacts provided by you when you register for the conference above, has the purpose of managing the registration to the conference, managing the communications needed for the participation in the event and any associated requirements. The data treatment, object of this notice will be performed at the Owner's legal headquarters listed at item 1 and at the site of the event organized by the Owner, using procedures, also automatic and computerized procedures, with the necessary modalities and limitations in furtherance of the purposes mentioned above. Your data will be treated only by specifically designated operators, who are trained and appointed by the Owner.

3. Need for providing data.

If you do not provide to the Owner the personal information requested, it will not be possible to manage your registration to the conference mentioned above.

4. Data treatment legal bases.

The legal bases for the treatment is “legitimate interest” for the execution of a contract with the interested party, or the performance of precontractual measures adopted at the request of the interested party (Art. 6 – 1.b of the EU Regulation), or the management of the activities and communications necessary for your participation at the conference above.

5. Procedures for the data treatment and storage.

Data treatment will be performed by operators manually and/or automatically and electronically to store, manage and transmit the data, with logics strictly associated to the purposes indicated at item 2. of this notice.

Under letter e) of Art. 5 of the European Union Regulation N. 2016/679, personal information will be stored by the Owner for a duration no longer than the time needed to fulfill the legal requirements, based on the tasks and purposes described in this notice.

6. Area of data sharing.

In the context of fulfilling legal requirements, and managing your registration to the event. Please note that, in the limits strictly necessary for the provision of the services requested, your personal data may be shared with third parties located within the European Union, as well as outside the European Union. Any transfer outside the EU is governed by specific contracts requesting the receiver to comply with the appropriate guarantees under the applicable law.

7. Rights you may exercise.

Please note that articles 15 to 22 of the European Union Regulation N. 2016/679 give you specific rights (access, correction, deletion, limitation, objection and portability) related to the treatment of your data, which you can exercise toward the Treatment Owner; you also have the right to submit a complaint to the Guarantor Authority for the Protection of Personal Information (website: www.garanteprivacy.it) if your rights or the rights of the person you represent are violated. You can exercise those rights sending a written request to "LuovoDiColombo", at the Owner address indicated at item 1. of this notice.
